**NOTICE INVITING APPLICATIONS FOR PITCHING BOARDING-TENTS/ SHOP-TENTS  
SHRI AMARNATHJI YATRA 2013**

1. Applications are invited from individuals/ agencies for grant of permission to pitch boarding-tents/ shop-tents at various Yatra Camps along both the routes, i.e. Baltal and Pahalgam, for Yatra 2013.
2. The permission shall be granted on first-come-first-served basis to those applicant stake-holders who procure tents of quality equal to or superior to that approved by the CEO, SASB/ Committee, consequent to the demonstration on 10<sup>th</sup> October 2012 at Raj Bhavan, Srinagar and, later, displayed at PWD Dak Bungalow, Kangan and Nunwan Base Camp till 9<sup>th</sup> January 2013. Preference would be given to eligible applicants from among those who had obtained permission to pitch tents during Yatra 2010 and Yatra 2011.
3. Members of Bota Malik Labour and Contract Cooperative Ltd. (BMLC), the descendents of Bota Malik Paribar, shall also be given preference for grant of Tent Permission if they fulfil the prescribed conditions/ criteria.
4. Other things being equal, 1st, 2nd and 3rd preference shall be given to the residents of Tehsils Pahalgam, Bijbehara and Anantnag, respectively, in respect of the Pahalgam-Holy Cave sector. Similarly, 1st, 2nd, and 3rd preference shall be given to the residents of Tehsils Kangan, Lar, and Ganderbal, respectively, in respect of Baltal-Holy Cave sector.
5. No individual/ family shall be issued permission to pitch more than two tents in the Yatra area.
6. The applications in prescribed format (available in Tehsil Office Kangan/ Pahalgam) should be accompanied with the following:
  - a) Original Tent Permission issued in respect of Yatra 2010 and Yatra 2011.
  - b) Police Verification Report issued after 20<sup>th</sup> November, 2012.
  - c) A self attested undertaking that the applicant shall procure tent/ beddings as per the specifications/ quality equal to or superior to the quality approved by SASB/ District Administration by 10<sup>th</sup> January 2013. (The sample tents approved, to be procured by the applicants, shall be pitched for demonstration at Nunwan Base Camp and PWD Dak Bungalow, Kangan).
  - d) A certificate from Divisional Fire Officer, Anantnag/ Ganderbal to the effect that applicant owns a portable fire extinguisher for installation in the tent.
  - e) An undertaking to the effect that he would abide by the Terms and Conditions listed in the Permission letter.
  - f) An undertaking to the effect that no other member of his family has applied for issue of the Permission for boarding-tent/ shop-tent.
7. The applications, along with aforementioned documents, shall be submitted at the following locations on the scheduled date and time:
  - a) Tehsil Office, Kangan : 5<sup>th</sup> December – 25<sup>th</sup> December 2012 from 10 AM to 4 PM.  
(Baltal – Holy Cave route).
  - b) Tehsil Office, Pahalgam : 5<sup>th</sup> December – 25<sup>th</sup> December 2012 from 10 AM to 4 PM.  
(Nunwan – Holy Cave route).
8. The permission will be issued subject to the agreement to abide by the prescribed Terms and Conditions and on payment of a fee of Rs.100/- for each boarding-tent, and Rs.600/- for each shop-tent.
