## Terms and Conditions

1. The rates quoted shall be FOR Chaitanya Ashram, Tallab Tillo, Jammu and shall be inclusive of all Taxes / Levies etc.
2. The bids in sealed covers should reach the office of **Additional Chief Executive Officer**, Shri Amarnathji Shrine Board, Chaitanya Ashram, Tallab Tillo, Jammu on or before **24.03.2014** upto 1400 hours.
3. The Bid Opening Authority reserves the right to reject / accept any or all Quotations without assigning any reason thereof.
4. The bidder shall have to deposit EMD of **Rs 20,000.00** in the shape of FDR / CDR in favour of Chief Accounts Officer, Shri Amarnathji Shrine Board.
5. The bidder should provide a certified copy of the Registration Certificate and copies of the following items with Quotation:
  - i. Attested copy of the company's / Manufacturers / Dealers Registration Certificate.
  - ii. Attested copy of PAN Card issued by the Income Tax Department.
  - iii. Detailed specifications of the material offered, which must conform to the prescribed specifications.
  - iv. Information as per Format **Annexure "A"**.
6. The documents mentioned in the preceding para, EMD and the bid shall be put in an envelope, duly sealed and supercribed as follows:  
"Quotation for Supply of G I Pipes and Mild Steel Pipes for Shri Amarnathji Shrine Board".
7. The bid shall remain valid for a period of six months from the last day of receipt of bids.
8. The successful bidder shall be awarded the Contract to supply the material mentioned in the bid within 15 days of issue of Contract.
9. The Earnest Money of successful bidder shall be retained as security deposit and returned on completion of Contract. The EMD shall be returned to the successful bidder.
10. The supply must be completed within the stipulated period, failing to which CEO, SASB shall have the right to purchase the non supplied goods at suppliers risk and impose penalty for delayed supply in the following manner:
  - a. Upto 15 days @ 1%.
  - b. From 16<sup>th</sup> day upto 22<sup>nd</sup> day @1.5%.
  - c. From 23<sup>rd</sup> day upto 30<sup>th</sup> day @2%.
  - d. Beyond 30<sup>th</sup> days the supply order will be deemed to have been cancelled, and security deposit / EMD shall be fortified in favour of Shri Amarnathji Shrine Board, Jammu, where after the supplier will be debarred from any further dealing with Shri Amarnathji Shrine Board.
- 11 Shrine Board reserves the right to enter into negotiation with any bidder or accept or reject any / all offers without assigning any reason.

12 The successful firm will have to enter into an agreement to fulfil the contractual obligations with a period of one week from the date of issue of Letter of Award of Contract.

13 Conditional bids shall accept and shall be treated as null and void:

(a) The payment shall be made after receipt of complete supply and due verification of quantity / quality thereof by GM (Works)

14 **Jurisdiction:**

All questions , disputes, or difference arising under and out of , in connection with the contract, if concluded, shall be subject to the jurisdiction of Court at Jammu, (J&K).

15 **Arbitration:**

In case of any dispute arising between the parties relating to the supply, the Additional Chief Executive Officer, Shri Amarnathji Shrine Board, will be the arbitrator and his decision be final and binding upon both the parties.
