The bidder, in their own interest, is advised to deliver the bids personally to the office of General Manager (Wrks), Shri Amarnathji Shrine Board, 2nd Floor, Block-III, Engineering Complex, Raj Bagh, Srinagar-190008. Alternatively, he may send the same through courier/ registered post. The Board will not be responsible for any delay, wrong delivery or non-delivery of the bids due to any reason.
4. The Technical Bids shall be opened at 1500 hours on 19.05.2022 in the office of General Manager (Works), SASB, 2nd Floor, Block-III, Engineering Complex, Raj Bagh, Srinagar in presence of authorised representatives of the agency who may wish to be present.

## **I. Short Term Notice Inviting Bid**

1. Transportation of Stores, Officers/ Officials & Mess materials etc. by hiring of ponies with handlers and carriage of material by porters/ pithus along Baltal axis and Pahalgam axis for the duration of Shri Amarnathji Yatra – 2022.
2. The Bidder shall quote its offer inclusive of all taxes and charges for Transportation of Stores, Officers/ Officials & Mess materials etc. by hiring of ponies with handlers along both axis (Pahalgam & Baltal) for the duration of Shri Amarnathji Yatra – 2022
3. Detailed NIT (DNIT) can be downloaded from SASB's website [www.shriamarnathjishrine.com](http://www.shriamarnathjishrine.com) upto **18.05.2022** in which the cost of DNIT shall be payable through Demand Draft (non refundable) drawn in favour of FA/ CAO, Shri Amarnathji Shrine Board, payable at Srinagar.
4. The bidder shall enclose with his bid a CDR/ FDR for an amount of **Rs. 1,00,000/-** (one lakh only) as Earnest Money Deposit, pledged to the FA/ CAO, Shri Amarnathji Shrine Board. The bid along with Earnest Money Deposit and cost of DNIT should be dropped in the tender box kept in the office chamber of General Manager (Wrks), SASB at 2nd Floor, Block-III, Engineering Complex, Raj Bagh, Srinagar-190008 by or before 19.05.2022 upto 1400 hours.
5. The successful bidder shall have to deposit additional CDR/ EMD of Rs 1,00,000/- as security deposit and execute an agreement with the General Manager (Works), SASB before issuance of Letter of Award (LoA).
6. In case the last date of receipt of Bid happens to be a holiday, the Bid shall be received on the next working day up to 1400 hours.
7. The Bids will be opened on **19.05.2022 at 1500 hours** in the office chamber of General Manager (works) in presence of authorized representatives of bidders who may wish to be present on the occasion.

## **II. Instructions to Bidders**

- a) The bidders are required to invariably quote their rates inclusive of all taxes and fare charges in the enclosed Annexure (A) for Transportation of Stores, Officers/ Officials & Mess materials etc. by hiring of ponies with handlers and porters along both Baltal & Pahalgam axis for the duration of Shri Amarnathji Yatra – 2022 both in figures and in words, failing which their bid will be liable to be rejected. In case of any inconsistency the bid amount written in words will prevail. All entries in the bid should be legible and filled clearly, typed or written in ink. Bids written with pencil would not be considered. No overwriting or cutting is permitted. The Bidder shall not make or cause any alteration, erasure or obliteration to the text of the Bid. If any corrections have been made the same shall be neatly done and properly signed by Bidder, without which the bid shall not be accepted. Bids incomplete in any form or conditional bids will be rejected.

- b) The Shrine Board shall issue Letter of Intent (LoI) to the successful lowest bidder for deposit of additional CDR/ FDR of Rs 1,00,000/- as discussed at (I. 5) above and execute the Agreement with the General Manager (Works) Shri Amarnathji Shrine Board for Transportation of Stores, Officers/ Officials & Mess materials etc. by hiring of ponies with handlers and porters.
- c) The Letter of Award (LoA) shall be issued in favour of the successful bidder after he complete the requirements as discussed at Clause-b above.
- d) After issue of Letter of Award (LoA) the vendor shall have to provide a detailed list of the persons (handlers) indicating their name and address with their place of deployment, supported by police verification report regarding their address and to the effect that they are not involved in any antinational activity.
- e) The bidder is advised in its own interest, to have sufficient information about the working site before submitting the bid.
- f) Bids must be received at the address specified above not later than the date and time stipulated in the bid notice. Incomplete Bids, or bids without requisite Earnest Money and Tender Fee or Bids received by the Shrine Board after the stipulated last date & time shall not be considered.
- g) The Bids will be opened on **19.05.2022** at **1500 hours** in the Office chamber of General Manager (Works), Shri Amarnathji Shrine Board, 2<sup>nd</sup> Floor, Block-III, Engineering Complex, Raj Bagh, Srinagar, in the presence of Bidders who may wish to be present on the occasion.
- h) Each paper of the bid document should be complete in all respects and signed by the bidder/ his authorized representative.
- i) Canvassing in connection with Bids in any form is strictly prohibited, and if resorted to, will render the Bidder disqualified and Earnest Money will be forfeited.
- j) The Bid shall remain valid and open for acceptance for a period of 30 days from the last date of receipt of Bid. The Earnest Money shall be forfeited if the Bidder withdraws his Bid during the period of Bid Validity Period.
- k) The Shrine Board may, at its discretion, extend the last date for submission of Bids in which case all rights and obligations of the Shrine Board and bidder will be the same.
- l) The Chief Executive Officer, Shri Amarnathji Shrine Board is not bound to accept the Lowest or any Bid and may, at any time by notice in writing to the Bidders, terminate the Bidding process.
- m) The Chief Executive Officer, Shri Amarnathji Shrine Board reserves the right to reject all or any Bid in whole or in part, without assigning any reason. Any enquiry to this effect will not be entertained.

### III. **Terms and Conditions of Contract:**

1. The supplier shall furnish to the Shrine Board, a list of workers (Camp-wise) to be engaged by him for the Transportation of Stores, Officers/ Officials & Mess materials etc. by hiring of ponies/ porters along with the recent Police Verification Report.
2. The payment on account of supply of ponies/ porters shall be made after deduction of taxes as applicable.
3. Before the payment is released by the Shrine Board to the supplier, the supplier shall have to provide copy of valid PAN Card and GSTIN certificate.
4. The supplier shall make proper arrangement for the comfortable stay of workforce.
5. The Supplier shall engage physically fit handlers/ porters whose age shall be between 18-55 years. Each handler/ porter so engaged by the Contractor shall wear uniform as approved by the competent authority and a badge wearing his name, while on duty. The said uniform shall be provided by the supplier at his own cost.
6. The ponies against animal diseases and abide by the prevention of cruelly animal Act 1960 is to be engaged by the supplier/agency must be vaccinated.
7. The saddle of the ponies for transportation of persons shall conform the standard specifications and bed sheet/ blanket case of saddle shall be fresh and replaced with washed once after every use.
8. The supplier/ agency shall be solely responsible for Workmen's Compensation Act, 1923 for payment of compensation to workmen and their dependants in case of injury and accident (including certain occupational disease) arising out of and in the course of employment and resulting in disablement or death.
9. During the course of Contract, if any of the Supplier's personnel is found to be indulging in any mal practice, conduct inimical to the interest of the Yatri/ Shrine Board, breach to Terms and Conditions of the Agreement including any corrupt practice, fine upto Rs. 1,000/- per such instance may be imposed and CEO, Shri Amarnathji Shrine Board shall have the right to terminate the Agreement and make such alternate arrangements as shall be deemed just and proper for smooth transportation of stores.
10. The Supplier shall abide by all rules and regulations, as amended from time to time, notified by the Shrine Board and maintain the sanctity of Shrine and not indulge in any activity which is prejudicial to the sanctity of the Holy Shrine. Staff of the Supplier shall not indulge in smoking or consumption of liquor/ alcohol or consumption of any non vegetarian food articles. They shall maintain proper decorum and discipline and

ensure proper conduct in speech and dress. They shall also refrain from any other activity which might hurt the sentiments of the Officers/ Staff/ Yatris.

11. In case of occurrence of Force Majeure conditions, the agency shall promptly inform CEO, SASB about occurrence of such conditions. On receipt of the agency's Report and after ascertaining as to whether Force Majeure conditions exists (such as a Government Order/ Regulation, war, an accident creating a disturbed condition, terrorist activity, court order, strikes/ riots, civil commotion, pandemic like COVID-19 etc.) CEO, SASB shall suspend the agency's license. SASB shall not be liable for any damage or liability of any kind arising out of Force Majeure conditions and/ or any other cause beyond the reasonable control of SASB.
12. The Earnest Money of the Supplier will be released to the agency on the conclusion of the Yatra - 2022, after deducting the outstanding/ penalty if any, recoverable from the supplier. The Earnest Money will be subject to forfeiture in case of violation of any of the Terms and Conditions of the Agreement besides further such actions as the Chief Executive Officer, Shri Amarnathji Shrine Board may consider necessary under the given circumstances.
13. The contract shall be extendible for Yatra period of 2023 subject to;
  - i. Good performance & Conduct by the agency in Yatra-2022
  - ii. the agency shall have to apply for such extension within two months of culmination of Yatra 2022
  - iii Approval of Chief Executive Officer SASB
  - iv. In such case of approval earnest money of tenderer shall be retained.
  - iii. Subject to approval, Letter Of Intent issued for depositing of Royalty amount & drawl of agreement shall be issued
  - v. After depositing of royalty amount as per previous LOA and drawl of agreement, Letter of Award shall be issues
14. The Chief Executive Officer, Shri Amarnathji Shrine Board reserves the right to reject any or all the tenders without assigning any reasons thereof.
15. In the event of any doubt, dispute or difference of opinion in regard to terms & conditions of the agreement, the concerned parties shall endeavor to settle the same amicably with the SASB through any officer nominated in this behalf. In case, any such doubt, dispute or difference of opinion remains unresolved, the matter shall be referred to the Hon'ble Lieutenant Governor, J&K (Chairman of SASB), who shall be competent to refer the same to any retired Hon'ble Judge of the High Court of Jammu Kashmir & Ladakh for its resolution. The decision so rendered or award, if any, passed shall govern the rights, duties & obligations of the concerned parties and shall be final. No such disputes shall be referred during the currency of the Yatra.
16. All questions relating to the arbitration shall be determined in accordance with provisions of the Arbitration and Conciliation Act, 1996 and the amendments thereto and any re-enactment or modification thereof and the rules framed there under.
