Short Term Notice Inviting Quotations

Sealed Quotations affixed with Rs 6/- revenue stamps are invited from the registered SSI unit holders for Fabrication and Supply of following items required for Shri Amarnathji Yatra – 2018. The quotations should reach the office of General Manager (Works) **on or 16th April, 2018 upto 1400 hour;**

- i. Mild Steel sitting benches: = 60 Nos.
2. The tender document can be obtained from the office of FA & CAO, SASB from 06.04.2018 to 12.04.2018 (9.00 am to 5.00 pm and 9.00 am to 1.00 pm on 16.04.2018 against a cash payment of Rs 200/-. Alternatively the documents can be downloaded from our website: www.shriamarnathjishrine.com. In which case the cost of document shall be payable along with the document in the shape of Demand Draft pledged to FA & CAO, SASB at the time of submission of bid.
3. The samples for these items are already available for inspection by the bidders in the office premises of Shri Amarnathji Shrine Board, Jammu.
4. Rates quoted by the bidders should be inclusive of all taxes and levies and FOR Baltal Base Camp;
5. The lowest bidder shall have to fabricate 1 Bench as per approved drawing and Sample for inspection and subsequent approval by General Manager (Works).
6. The lowest bidder shall have to give and undertaking for replacement of any defect found in welding, which shall be got replaced by the agency on his own cost for one year from the dispatch of material.
7. The Tender Opening Committee shall open the quotations on 16th April, 2018 at 1500 hours in presence of bidders who wish to remain present.
8. The Tender Opening Committee reserves the right to reject/ accept any or all Quotations without assigning any reason thereof.
9. The material shall be fabricated and supply within 30 days from the date of issue supply order.
10. The successful bidder shall have to deposit 2% of allotted amount in the shape of CDR/ FDR pledged to FA & CAO, SASB as Security Deposit and shall have to execute an agreement with General Manager (Works) within 10 days from the date of receipt of LoI.

11. In case of failure to supply the material within the stipulated period, the following penalty shall be imposed upon supplier for the delays.
 - i. upto 15 days @ 1%
 - ii. from 16 days upto 22 days @ 1.5%
 - iii. from 23 days upto 30 days @2%
 - iv. beyond 30 days, the supply order will be deemed to have been cancelled without any further correspondence with you firm regarding the subject cited above, and the security deposit will be forfeited.
12. The payment shall be made to the supplier after material is received and bills verified by the concerned JE.
