Sealed Quotations affixed with Rs 6/- revenue stamps are invited from the registered service centers/ dealers having valid registration for servicing of Kent Water Purifiers, Acqua Guards for following item of work required for Shri Amarnathji Yatra – 2018. The quotations should reach the office of General Manager (Works) **on or before 12th June, 2018 upto 1400 hrs;**

Alternatively the documents can be downloaded from SASB website: www.shriamarnathijishrine.com in which case the cost of document shall be payable along with the document in the shape of Demand Draft pledged to FA & CAO, Shri Amarnathji Shrine Board.

3. The quotation shall be accompanied with Earnest Money Deposit in the shape of CDR/ FDR equivalent to 5% of the quoted amount pledged to FA & CAO, Shri Amarnathji Shrine Board, any quotation not attached with CDR/ FDR shall be out rightly rejected.

4. Rates quoted by the bidder should be inclusive of all taxes and levies.

5. The material supplied shall be of high quality, standards and confirming to IS specifications.

6. The bidder shall have to give an undertaking for replacement of any defect found in item.

7. The Tender Opening Committee shall open the quotations on 12th June, 2018 at 1500 hours in presence of bidders who wish to remain present.

8. The Tender Opening Committee reserves the right to reject/ accept any or all Quotations without assigning any reason thereof.

9. The servicing and installation of Kent at designated location shall be completed within 15 days from the date of receipt of supply order.

10. The bidder shall submit his quotation strictly as per the schedule A & B as per the Tender Document. Conditional tender shall be out rightly rejected.

11. All entries in the Technical Bid (A)/ Financial Bid (B) should be legible and should be free from corrections/ erasures/ overwriting/ cuttings. Bids with corrections/ erasures/ overwriting/ cuttings shall be out rightly rejected.

12. In case of failure to the job within the stipulated period, the following penalty shall be imposed upon for the delays.

- i. upto 4 days @ 1%
- ii. from 5 days upto 9 days @ 1.1/2%
- iii. from 10 days upto 13 days @2%
- iv. beyond 13 days, the supply order will be deemed to have been cancelled without any further correspondence the firm regarding the subject cited above, and the security deposit will be forfeited.

13. The payment shall be made to the selected agency after the completion of job and bills verified by the concerned DGM's.

14. The kents are available at our Central Store, Srinagar and Nunwan Base Camp for inspection and are to be transported to the designative sites from these two places.

15. The Earnest Money Deposit in the shape of CDR/ FDR of the unsuccessful bidder shall be released after issue of the work order in favour of the successful bidder.

16. The initial period of the contract of one year i.e. Yatra – 2018 (confirming to the Yatra duration as decided by the SASB) may be extended for a period of one more year i.e. Yatra – 2019 subject to satisfactory performance of the agency and retention of Performance Security Deposit with SASB for next year as well on the same terms, conditions and rates as allowed for Yatra – 2018.
